A MESSAGE FROM OUR CHAIRPERSON



On behalf of Yarra Energy Foundation (YEF), I am pleased to share with you our Annual Report for the 2014-15 financial year.

I am very proud of the efforts of YEF and our key partners to develop and deliver strong and successful commercial programs. We continue to prove that we can successfully transition to a sustainable low carbon future for the community. Some of the key highlights of the year included:

- The YEF Commercial Solar Program has enabled us to leverage our expertise in solar to extend to residential and targeted solar school programmes
- Australian Vietnamese Women's Association (AVWA) energy efficiency programme
- Strong partnerships with IKEA and the Yarra City Council have helped make it easier for businesses to invest in Solar PV and energy efficiency initiatives
- Our ability to engage and connect into the community has again been reflected in the excellent attendance at our various business and community events

Despite experiencing tough regulatory market conditions for a low carbon economy in Australia over the last few years, there are a number of significant emerging developments on global, national and state level. Of particular interest will be the 21st Conference of the Parties to the UN Framework Convention on Climate Change

(COP21) held in Paris at the end of 2015. The aim of these meetings is to reach a global agreement to combat climate change and to promote a transition towards resilient, low-carbon societies and economies.

In addition, we are also seeing increasingly supportive Federal and State Government Initiatives that should lead to greater opportunities for financial incentives, innovative financing and partnerships. Coupled with the introduction of disruptive technological solutions, YEF is well placed to take advantage of these opportunities. A good example that we are preparing for is the recent Victorian legislation on Environmental Upgrade Agreements (EUA) which is an innovative financing tool targeting the retrofit of commercial buildings.

I would like to acknowledge the Yarra City Council for their tremendous support for their shared vision of achieving of a carbon neutral city. Our success is largely attributable to the passionate and dedicated efforts of the YEF team and our valued partners. I would like to offer my deep gratitude to all involved throughout the year for their continued commitment, enthusiasm and hard work.

On behalf of the Board, I would also like to recognise the great work and service that the former CEO Kate Nicolazzo provided to the organisation and we extend a warm welcome to the new CEO, Sarah Johnson.

THE BOARD

Jennifer Lauber Patterson is the Chair of Yarra Energy Foundation. She is the Co-Founder and Executive Director of Frontier Energy and is the Head of the Climate Markets and Investment Association for Australia and New Zealand.

Jennifer was named one of the 100 Global Sustainability Leaders by ABC Carbon in 2012 and 2013.

Gerard has been a consumer lawyer and advocate for over 10 years, and previously worked with the Brotherhood of St Laurence. Gerard has a Masters in Public Policy and Management, Bachelor of Laws (Hons) and Bachelor of Arts (Hons) from the University of Melbourne.

Geoff Mabbett is the Director and Owner of Lime Consulting, specialising in executive coaching, organisational alignment and strategy development. He is also the Chairman of the Advisory Board of the Net Balance Foundation, Chairman of the Sustainable Forestry Council and the Victorian Director of LSI Consulting. His executive career included 10 years as a Chief Executive in the utilities and environmental services industries including serving as the inaugural CEO of Sustainability Victoria from 2005 to 2007.

Dr. Peter Christoff is Coordinator of Environmental Studies within the Melbourne School of Land and Environment at the University of Melbourne. He is also a Visiting Research Fellow at the Monash Sustainability Institute. He is a Board member and a former Vice President of the Australian Conservation Foundation. He was also formerly a member of the Victorian Premier's Climate Change Reference Group, the Victorian Ministerial Reference Council on Climate Change Adaptation, and Assistant Commissioner for the Environment (Victoria).

Cr Sam Gaylard has been a Greens Councillor representing the Nicholls Ward (North Carlton, North Fitzroy, Princes Hill, and parts of Fitzroy, Clifton Hill and Collingwood) since 2008. He is a member of Council's Planning, Environment and Infrastructure Committee and of the Bicycle Consultative Committee and the Community Gardens Advisory Committee, and is a founding councillor representative on the Yarra Energy Foundation. Cr Gaylard believes local government can play a pivotal role in tackling climate change and supporting our community's transition to a sustainable and resilient future. Previously, he has worked as a social worker, a manager at the Fitzroy Council, an executive officer in a development education organisation, an industrial officer at the ASU servicing the Community and Local Government sectors and has worked for a Greens MP.

Guy Wilson-Browne is currently the Director City Works & Assets for Yarra City Council, responsible for the overall planning, provision and maintenance of public infrastructure for Yarra City Council. Guy is a Fellow of the Australian Institute of Company Directors and is also a Board Director for Westernport Water. He has more than 15 years experience as a senior manager in the public infrastructure sector. His qualifications include a degree in Civil Engineering and Graduate Diplomas in Business Administration (Leisure & Tourism) and Commercial Law.

Dr. Katherine Dean is founder and director of D3 Consulting Group. She is recognised as one of Australia's leading scientists in the sustainable materials field with over 20 years of experience in technology innovation, strategy, business and global engagement within the materials R&D sector.





Working with **business** and organisations across Yarra, we are developing targeted **campaign led programs to help our aged care facilities, child care, schools and our wide ranging business sector to access information**, advice, products and services they need to reduce their footprint to zero.

Working with our **residents** we are developing programs that aim to reach some of the most vulnerable people, as well providing trusted information for those already ready to take the next step.

By targeting our programs, we will **deliver** practical programs and pathways to solutions that will help our community reduce energy use.

OUR KEY PROJECTS AND INITIATIVES

COMMERCIAL SOLAR

Our Commercial Solar program has been designed and piloted over a 12-month period in consultation with community and industry leaders in order to facilitate investment into solar energy for local businesses. YEF identified that many businesses can benefit from an annual return in excess of 15-20% of the installation cost, depending on the time of energy use, electricity price and available space for installation.

Over the last year our program has helped businesses understand the potential savings available from solar power and then, if the business case stacks up, we help match businesses with trustworthy suppliers who can provide competitive quotes. In return for this service YEF receive a 5% commission from the solar provider for any installed systems.

In the last six months we have facilitated seven Commercial installations and we are continuing to work with our partners to connect our local business to quality energy efficiency and renewable solutions, and increasingly clean energy opportunities.

CASE STUDY: HUDSON'S FAMOUS CATERING

RESIDENTIAL SOLAR

This year we worked collaboratively with the City of Yarra and a local initiative called **solar** neighbourhoods to deliver a targeted bulk buy program. The total capacity contracted through solar neighbourhoods reached 278.5kW installed.

The community donation aspect of the program resulted in additional 21kW of solar PV systems made available to donate to a community organisation within the City of Yarra, donated from YEF and CommPower.

The criteria used to identify the community organization included being shovel-ready, not for profit, having a suitable roof and being an organisation that could benefit from a small system.


The first recipient was St Mary's House of Welcome, which provides meals, hot showers and clothing to an average of 200 people every day, together with dignity and choice. They received an 8kW installation.

We are continuing to work with our partners to develop affordable and efficient programs to help us reach more people with more options to reduce energy use and increase affordability and access to renewable energy options.

OUR KEY PROJECTS AND INITIATIVES

SMART SOLAR FOR YARRA SCHOOLS

Drawing on the experience gained with Richmond West Primary School we have launched a targeted Schools campaign in partnership with Cherry Energy Solutions. We aim to invite Principals and Presidents of Parents Groups to an information session, and attendees are provided with a follow up from YEF and Cherry Energy Solutions to assess their school's needs and facilitate an appropriate solution.

CASE STUDY: RICHMOND WEST PRIMARY SCHOOL

With a desire to minimise their school's carbon footprint, Richmond West wanted to upgrade their existing 5kW solar PV system. Through an installation of an additional 20kW plus LED retrofits, the school has now saved significantly on energy costs and reduced their carbon emissions by more than 66 tonnes annually.

Let's Begin...

An important first step for Richmond West was replacing their existing lights with LEDs. Over 250 lights were changed resulting in initial savings to lighting costs of 62%. A far more efficient option than fluorescents, this positioned the school well to use solar for the bulk of their ongoing energy needs. LEDs are also rated to last up to 50,000 hours, which considerably reduces ongoing maintenance costs.

Why Solar?

YEF and Cherry Energy Solutions determined that for Richmond West, a solar panel installation had potential to dramatically reduce the school's reliance on external energy provision from the grid. A 20kW solar system was installed on the school's roof. As the school uses almost all it's energy during daylight hours, solar power can meet the bulk of ongoing energy demands, and provides even more than what is needed during midday hours.

The Opportunity

The school implemented their project via a Sustainable Melbourne Fund repayment plan. The current Federal Incentive program, available through Cherry Energy Solutions, reduced the cost of the solar system by about \$12,000. The overall project was cashflow positive over the life of the funding period.

"Richmond West Primary School has a history of sustainability.
Part of our big picture plan is to reduce the school's footprint across a range of areas such as energy, recycling, water usage, kitchen gardening, composting and increasing active transport across the community. Solar panels and an LED retrofit was seen as the next logical step in achieving these long term goals."

What We Did

YEF and Cherry Energy Solutions worked together to support Richmond West to transition to low-carbon energy use. The amount of energy information and options available to organisations can be overwhelming, however YEF and Cherry were able to provide the most useful and relevant information, services and outcomes tailored specifically to Richmond West's needs, desires, and budget.

With the goal of reducing carbon use in the City of Yarra, YEF is proud to have partnered with Richmond West and continues to offer services free of charge to achieve similar outcomes in other schools.


The Result

Through a process of energy efficiency measures combined with a solar installation, Richmond West PS has achieved annual savings of over \$13,000, energy savings of over 53,000kWh per year and annual emission reductions of more than 66 tonnes.

In addition to this, Richmond West installed an information display screen that provides the real-time energy use of the school and energy production of the solar panels. This provides a uniquely engaging way of educating students about solar, and bringing a level of excitement to the school community about their achievements in reducing carbon emissions.





COMMUNITY ENGAGEMENT


Engaging the community is a critical function for Yarra Energy Foundation and has been a key focus of the team in the past twelve months. We define engagement as: the total number of people or organisations who interact with YEF communications, education, business development, marketing and social media activities.

ENERGY INFORMATION CAMPAIGN -VIETNAMESE COMMUNITY

YEF partnered with the Australian Vietnamese Women's Association Inc. (AVWA) to develop a Vietnamese language print, radio and video outreach program targeting the more than 86,000 Vietnamese-speaking Victorians.

The program was developed to engage consumers, facilitate the spread of information and drive informed choices around electricity pricing, including electricity markets, smart meters and flexible pricing. Specifically the program delivered:

Vietnamese-language flexible pricing infographic distributed in pamphlet and poster form (5,000) and published in Vietnamese language newspaper the Viet-Times. This infographic was also produced in English and translated by the Ethnic Communities Council of Victoria into six other languages. In addition, the project also delivered pamphlets and posters outlining three ways to save on electricity bills in English and Vietnamese.



Radio Spots covering the following content:

- Availability of flexible pricing and how it works for consumers:
- How consumers can make choices to save on energy costs;
- Use of the My Power Planner website to determine if flexible pricing is right for consumers, and how to work with retailers to select flexible pricing:
- · How users can combine energy efficiency and flexible pricing to lower energy costs.

5 Video Case Studies using real people from the Vietnamese community and focus on choice in energy plans and pricing, energy efficiency opportunities as well as using smart meter data and available tools such as My Power Planner to make informed decisions.

3 COMMUNITY ENERGY EXPOS

In addition to the original project plan, the project the team delivered:

- An energy expo attracting 150-200 community members. We have now delivered 3 of these expos across Melbourne.
- Energy information sessions and "bring your bill" sessions were incorporated within the expo as requested by key community groups across the state. These could be ongoing deliverables within community.

LIVEWELL CLUSTERS



In partnership with the City of Yarra, YEF is supporting the Low

Carbon Living Co-operative Research Centre's Livewell Clusters program being delivered through Curtin University.

Livewell Clusters are groups of households in the City of Yarra who will receive help to work together towards low-carbon living. Community

members joining the program will decide on and collaboratively work towards carbon-reduction targets with support from university researchers, YEF, council and other local organisations. This supported self-help approach will focus on how low-carbon living can maintain and even enhance wellbeing. Participation for the program will build through innovative social networking. YEF is supporting the program design, recruitment and evaluation.

PROUD TO BE YARRA SUSTAINABLE LIVING FESTIVAL


In 2015 YEF designed, organised and executed this one-day festival - Proud to be Yarra. PROUD TO BE YARRA - OBJECTIVES

- To engage the entire City of Yarra with our vision for building a thriving zero carbon community.
