MESSAGE FROM THE CHAIR

2013/14 was a period of restructure, change and growth for the Yarra Energy Foundation (YEF).



The Board has articulated a new level of clarity in YEF's strategic direction. We are a for-purpose organisation with a big goal – to achieve a zero carbon future for the City of Yarra. We will operate as a lean, focused team that aims to develop an income

Making it easy for businesses and residents to transition to a low carbon future.

While there are lots of people who have contributed much to the organisation in the past 12 months I would particularly like to thank Cam Nguyen from the Australian Vietnamese Women's Association Inc. Our partnership with Cam and her team allowed YEF to secure a grant from the Victorian Government that will provide energy related information and services to over 80,000 members of the Vietnamese-speaking community in Victoria. We will use this experience and the tools we develop through this project to work with other language and community groups in the future.

I would also like to thank YEF's immediate past Chair, Geoff Mabbett, for his significant contribution and leadership during his time as Chair in guiding YEF through a large transition.

I am very excited to be a part of the next stage of YEF's development and look forward to increasing our independence as well as growing our reach into and engagement with the community next year.

ABOUT THE YARRA ENERGY FOUNDATION

The Yarra Energy Foundation (YEF) is an independent, for-purpose organisation with a huge ambition – to achieve a zero carbon future in the City of Yarra by 2020.

We were established by Yarra City Council in 2010 and continue to receive significant support from the Council. YEF is governed by an independent board of highly skilled and experienced professionals.

We inspire the community by sharing stories, building networks and demonstrating what is possible in building a vibrant zero carbon future.

OUR PROGRAMS

YEF's primary program for community engagement and service delivery is Yarra Project Zero.

Yarra Project Zero will provide residents, businesses, schools and community organisations with the information, advice, products and services they need to reduce their footprint to zero. Yarra Project Zero focuses on increasing the uptake of energy efficiency and renewable energy.

YEF will also support other organisations, projects and programs operating within the City of Yarra that share our vision.

From time to time YEF will also work outside of the City of Yarra where it makes sense to do so. For example if a project or service provides a significant financial return for YEF that can be reinvested into the Yarra community or where efficiencies can be gained and outcomes extended by delivering a service or program at a larger scale, i.e. at a regional or state level.

This renewed clarity of direction has given YEF the boost that it needs to continue its transformation into a highly effective, outcomes focused organisation. The following report documents the early progress that YEF has made on this journey.

THE BOARD

JENNIFER LAUBER-PATTERSON

Jennifer is the Chair the Yarra Energy Foundation. She is the Co-Founder and Executive Director of Frontier Energy and is the Head of the Climate Markets and Investment Association for Australia and New Zealand. Jennifer was formally in senior executive roles in the electricity industry prior to setting up ANZ's Electricity and Environmental Markets Business and National Australia's Bank (NAB) Treasury Solutions Business. Jennifer has been named one of the 100 Global Sustainability Leaders by ABC Carbon in 2012 and 2013.

GERARD BRODY

Gerard is the Deputy Chair of the Yarra Energy Foundation. He is currently the Chief Executive Officer of the Consumer Action Law Centre, a campaign-focused consumer advocacy organisation. Gerard began his career in consumer advocacy as a policy officer and solicitor with Consumer Law Centre Victoria in 2004, before working as a Senior Policy Officer with Consumer Action. Gerard then worked with the Brotherhood of St Laurence as Senior Manager Financial Inclusion, leading the national rollout of the Saver Plus program. Gerard returned to Consumer Action in 2011 to lead the Centre's policy and campaigns work. Gerard has represented consumers on a number of bodies, including the Australian Competition and Consumer Commission's Consumer Consultative Committee, the Australian Securities and Investments Commission's Consumer Advisory Panel and the Australian Energy Regulator's Customer Consultative Group.

Gerard has a Masters in Public Policy and Management, Bachelor of Laws (Hons) and Bachelor of Arts (Hons) from the University of Melbourne.

GEOFF MABBETT

Geoff is the Director and Owner of Lime Consulting, specialising in executive coaching, organisational alignment and strategy development. He is also the Chairman of the Advisory Board of the Net Balance Foundation, Chairman of the Sustainable Forestry Council and the Victorian Director of LSI Consulting. His executive career included 10 years as a Chief Executive in the utilities and environmental services industries including the inaugural CEO of Sustainability Victoria from 2005 to 2007.

DR. PETER CHRISTOFF

Peter is Coordinator of Environmental Studies within the Melbourne School of Land and Environment at the University of Melbourne. He is also a Visiting Research Fellow at the Monash Sustainability Institute. He is a Board member and a former Vice President of the Australian Conservation Foundation. He was also formerly a member of the Victorian Premier's Climate Change Reference Group, the Victorian Ministerial Reference Council on Climate Change Adaptation, and Assistant Commissioner for the Environment (Victoria).

CR SAM GAYLARD

Sam has been a Greens Councillor representing the Nicholls Ward (North Carlton, North Fitzroy, Princes Hill, and parts of Fitzroy, Clifton Hill and Collingwood) for the past six years. He is a member of Council's Planning, Environment and Infrastructure Committee and of the Bicycle Consultative Committee and the Community Gardens Advisory Committee and is a founding councillor representative on the Yarra Energy Foundation. Cr Gaylard believes local government can play a pivotal role in tackling climate change and supporting our community's transition to a sustainable and resilient future.

Previously, he has worked as a social worker, a manager at the Fitzroy Council, an executive officer in a development education organisation, an industrial officer at the ASU servicing the Community and Local Government sectors and has worked for a Greens MP.

OUR KEY PROJECTS

The Yarra Energy Foundation implements a range of projects designed to engage all parts of our community with our vision and to give them the practical tools they need to start working towards our zero carbon future.

Below we introduce the eight key projects that have been the focus for the organisation over the past 12 months.

COMMERCIAL SOLAR

Yarra Project Zero's Commercial Solar program has been designed and piloted over a 12-month period in consultation with community and industry leaders in order to facilitate investment into solar energy for local businesses. YEF identified that many businesses can benefit from an annual return in excess of 15-20% of the installation cost, depending on the time of energy use, electricity price and available space for installation.

We launched our free service for businesses in Yarra on the 5th of June 2013. Our program helps businesses understand the potential savings available from solar power and then, if the business case stacks up, we match businesses with trustworthy suppliers who can provide competitive quotes. In return for this service the Yarra Energy Foundation receive a 5% commission from the solar provider for any installed systems.

YEF has contracts in place with seven solar companies that meet our criteria for quality and reliability. These companies are eligible to quote for YEF customers.



The business development activity is building steadily and at the 30th of June 2014 YEF had:

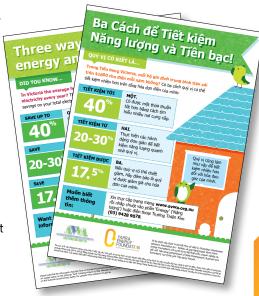
- 24 businesses in the pipeline,
- 3 considering feasibility reports,
- 4 at quote stage, and
- 2 at contract negotiation

ENERGY INFORMATION CAMPAIGN - VIETNAMESE COMMUNITY

YEF is partnering with the Australian Vietnamese Women's Association Inc. (AVWA) to develop a Vietnamese language print, radio and video outreach program targeting the more than 86,000 Vietnamese-speaking Victorians.

The program will be developed to engage consumers in order to foster the spread of information and drive informed choices around electricity pricing, including electricity markets, smart meters and flexible pricing. Through YEF's expertise the campaign will also provide education on energy efficiency opportunities.

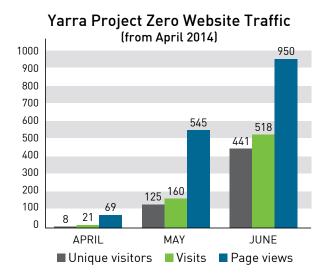
YEF will manage the project, in conjunction with AVWA coordinating the day-to-day running of the program and using the expert resources available within AVWA and the Vietnamese community to develop the campaign. YEF intends to develop this project and campaign in a way that it can be rolled out with other language groups in the future.



YARRA PROJECT ZERO WEBSITE

The Yarra Project Zero website

www.yarraprojectzero.org.au has been completely redesigned to be more accessible and easier to navigate for our range of audiences. Since republishing the website at the end of April the YPZ site has seen a steady increase in web traffic culminating in a total of 441 unique visitors viewing 950 pages in June alone.



YARRA PROJECT ZERO – THE PLEDGE

Towards the end of the year YEF developed a Yarra Project Zero pledge for businesses and individuals/households to sign as an indication of their commitment to a zero carbon future for Yarra. When they sign, they join our database and receive a sticker (for businesses) or logos for use in their social media and email correspondence (for households). These signed pledges, stickers and logos will become a key method of building the brand recognition for Yarra Project Zero, the goal of a zero carbon future throughout Yarra and building a coalition of committed and willing citizens who want to take action. The Ambassador program has been reinvigorated this year with the recruitment of three new corporate Ambassadors - IKEA Richmond, Collingwood Football Club and Yarra City Council. Yarra Project Zero Ambassadors lead by example. They help to show everyone thinking about starting their own zero carbon journey that they won't be alone, and that together we can create serious change.

IKEA Richmond are local leaders in renewable energy and are keen to share their stories and experience with other businesses that want to take advantage of the business opportunity. IKEA have installed over 700 kW at the Victoria Gardens store. The array is expected to be live

and operating in August 2014. "At IKEA, we understand we are reaching critical limits, but we're not interested in being just a little bit better, we are working all out on transforming our business. We are using sustainability as a driver for innovation and

Collingwood Football Club will not only promote Yarra Project Zero to their extensive network but are embarking on their own zero carbon journey with YEF, looking at energy efficiency and renewable energy at Victoria Park and the headquarters in Swan Street.

Yarra City Council has a depth of experience and knowledge in carbon reduction and energy efficiency throughout its buildings and operations, making them a perfect Ambassador for Yarra Project Zero. Yarra City Council will be sharing their story and experiences of building a zero carbon organisation with other Yarra businesses and will be encouraging all businesses to join in.

LIVEWELL CLUSTERS



In partnership with the City of Yarra YEF is supporting the Low Carbon Living Co-operative Research Centre's Livewell Clusters program being delivered through Curtain University.

Livewell Clusters are groups of households in the City of Yarra who will receive help to work together towards low-carbon living. Community members joining the program will decide on and collaboratively work towards carbon-reduction targets with support from university researchers, the Yarra Energy Foundation, council and other local organisations. This supported self-help approach will focus on how low-carbon living can maintain and even enhance wellbeing. Participation for the program will build through innovative social networking. YEF is supporting the program design, recruitment and evaluation.

LED LIGHTING



Through Yarra Project Zero YEF has developed a partnership with trusted Australian company cherryLED to deliver a quality lighting solution for businesses and households in the City of Yarra. The Yarra Project Zero program is delivered with the support of the Sustainable Melbourne Fund, where businesses and households can access the "Lighting that pays for itself" program. This program offers a payment schedule that offsets the upfront costs against the energy savings made. The LED program will be a key offer to households in 2014/15.

YARRA'S CARBON FOOTPRINT

YEF, with the assistance of the Northern Alliance for Greenhouse Action (NAGA), undertook an extensive project to update the annual greenhouse gas emissions (GHG) from stationary energy for the City of Yarra municipality. However, due to a range of data anomalies we do not have a level of confidence in the data to present it in this report. Instead YEF is working closely with the energy distribution network service providers to uncover the issues with the reported data and to gain a more confident picture of our community's carbon footprint.

Reporting a complete, progressive emissions baseline, in addition to adopting a robust data collection, reporting and analysis methodology, is essential in order to provide YEF, the Yarra City Council and the community with the information needed to target and evaluate emissions reduction activities now and into the future. That is why this project is a priority for 2014/15 and will be reported to the community and our stakeholders as soon as possible.

ENGAGING WITH OUR COMMUNITY

Engaging the community is a critical function for the Yarra Energy Foundation and has been a key focus of the team in the past twelve months.

We define engagement as: the total number of people or organisations who interact with YEF marketing, communication, education and business development activities. For example YEF counts any people who attended an event, meeting, signed the pledge or registered with the newsletter as engaged.

EVENTS

→ Sustainable Living Festival - Feb 2014

YEF had a stall at the Sustainable Living Festival promoting Yarra Project Zero and the LED Lighting Program. This resulted in 45 new Yarra Project Zero Registrations and three leads for LED lighting.



→ Energy Efficiency Office Buildings

YEF co-hosted a function with Sustainability Victoria and CitySwitch bringing over 40 participants from 32 organisations throughout the City of Yarra together to learn about the Energy Efficient Office Buildings program, CitySwitch program, and the Commercial Solar and LED programs from YEF.

→ Yarra Project Zero Business Program Launch

The launch of Yarra Project Zero's Business Program invited 121 local business owners and community stakeholders. 61 people attended, 13 of whom represented medium to large businesses (potential customers) in the City of Yarra, the majority of these have now become customers of the Commercial Solar program.

BUSINESS DEVELOPMENT

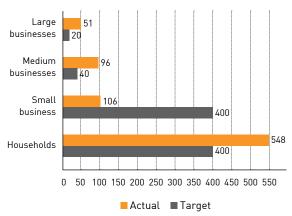
YEF has two part-time volunteers and one paid staff member (total of 1.2FTE) working on business development for Yarra Project Zero's Business Program. The team has been focused on leveraging the experience, networks and interests of our volunteers to pursue particular opportunities in a number of sectors. Namely energy intensive small

to medium businesses like those involved in the ever popular coffee roasting or micro-brewery industries, corporations mindful of their carbon footprint and responsibilities to the community, and schools demonstrating sustainable practices to the next generation.

OVERALL RESULTS

The graph below indicates that YEF has comfortably met and exceeded three of the four engagement targets for 2013/14. Unfortunately YEF has not been able to achieve its small business engagement target, this is in part due to the fact that small businesses are notoriously difficult to engage with and our primary program offering (Commercial Solar) is more ideally suited to medium and larger businesses, which is where we have focused our business development activity.

SOCIAL MEDIA

The Yarra Energy Foundation (YEF) has been working hard to build the social media profile of both the YEF and Yarra Project Zero brands. The results of those efforts are documented below.

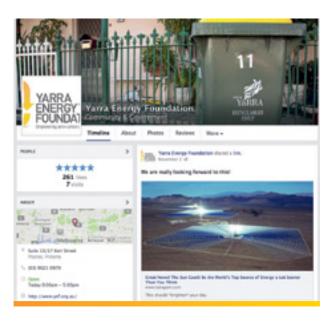
YARRA ENERGY FOUNDATION **FACEBOOK PAGE**

The YEF Facebook page has grown by 40% in the past six months up from 172 to a total of 246.

The YEF Facebook page is designed to focus on the macro issues such as government policies, regulation and legislation, international action and climate change science.

On average 17 people per week engage with the YEF Facebook page.

YEF also has a geographically diverse fan base with 20% of the fans located in other countries and 64% located in Melbourne.



YARRA PROJECT ZERO **FACEBOOK PAGE**

The Yarra Project Zero Facebook page focuses on action that individuals and organisations can take to achieve our zero carbon goal. After moving to a new Yarra Project Zero page in April at www.facebook. com/yarraprojectzeroypz it has been experiencing a high level of growth and engagement.

On average in the past few months the Yarra Project Zero page is receiving seven new likes each day and at the end of June 2014 had a total of 421 fans.

57% of Yarra Project Zero's fans are women, 40% are men and the remainder are unknown.

The fans on the Yarra Project Zero Facebook page have a relatively high level of engagement (liking, posting, sharing, clicking, reading) with an average of 17 users engaging with posts on the page every day.

Whilst at this stage it isn't possible to know exactly how many of the Yarra Project Zero fans are located in the City of Yarra we do know that the vast majority (95%) are based in Melbourne.



PRIORITIES FOR NEXT YEAR

While most of the Yarra Energy Foundations' existing programs and services will continue to be delivered in 2014/15, there are several projects that will be particular priorities for the year ahead.

PROUD TO BE YARRA

Sunday the 22nd of February 2015 will see the Yarra Energy Foundation host Proud to be Yarra, a festival celebrating sustainable living at the Abbotsford Convent. We will partner with reputable companies and not for profit organisations to offer a day of activities, entertainment, informational stalls and educational workshops to help people make changes in their lives - both big and small - to achieve a cleaner, greener and smarter City of Yarra. 2015 will be the inaugural year of the Festival but the intention is to make it an annual, and growing, event.

YARRA'S CARBON FOOTPRINT

Getting a complete and accurate picture of what is happening with the City of Yarra's Carbon Footprint is exceptionally important to YEF's goal of a zero carbon future. In 2014/15 we will be working to establish a partnership with Citipower, the major electricity distributor in the City of Yarra, to ensure we can get access to complete, accurate and up to date data. The electricity that is distributed by Citipower in the City of Yarra accounts for more than 90% of the carbon footprint attributable to stationary energy.

COMMERCIAL SOLAR

The Commercial Solar program is proving to be one of the most successful programs that YEF has ever initiated. However significant works still remains to make sure the program can deliver on its potential to engage businesses, invest in renewable energy, reduce carbon emissions and generate a return for YEF. 2014/15 will see the YEF team continuing to focus on delivering and building this program. The experience gained during the program will also

contribute to the development of a solar energy program for households to be launched in 2014/15 as well.

OUR HOUSEHOLD PROGRAM

In addition to developing a solar energy offer for households in 2014/15, the Yarra Energy Foundation will be delivering several other programs and services to households in the City of Yarra to help them reduce their carbon footprint. Our primary program will be the free Energy Helpline which will be offered through a partnership with Positive Charge.

THE ROADMAP TO ZERO

In partnership with Yarra City Council and other local groups, YEF has identified the need to develop a comprehensive plan to achieve net zero emissions from stationary energy within the City of Yarra. We are developing the Roadmap to Zero project to complete this goal. Through comprehensive community consultation and identification of all current technically and economically feasible options to reduce, replace or offset our emissions from stationary energy, YEF could determine the solutions most likely to be embraced by the community. Having this level of community ownership and buy in to the process of developing a Roadmap to Zero is the only way we will be able to achieve our ambitious goal.

The YEF team is looking forward to working with the local community and key stakeholders to develop a plan that is visionary and inspirational while still grounded in everyday realities and practicality.



CLIMATE REALITY TALKS

In June 2014 YEF's CEO Kate Nicolazzo completed the Climate Reality Training with Former US Vice President Al Gore and was inducted as a Climate Reality Leader. Kate expects to be delivering a range of climate change talks to community groups, workplaces, schools and anywhere else people want to listen in 2014/15. Climate Reality talks are a terrific chance to look at the opportunities around us to take local, meaningful action on climate change.

ORGANISATIONAL GROWTH

The Yarra Energy Foundation has an ambitious goal that can only be achieved if it can leverage significant investment from across the community and government to expand its resources and the scale of impact. Generating additional income, outside of the support we receive from Yarra City Council is critical to YEF's ongoing success.
